## GHANA - The GFZA and the Ministry of Trade and Industry are in the process of developing three separate industrial cities in the country





Vehicle manufacturing and food processing could reap billions from African free trade zone

Vehicle manufacturing and food processing have been touted as the next big drivers of intra-African trade as the single largest world market, AfCFTA, readies to enter its second implementation phase in less than a month. A new report, Reaping the potential benefits of the African Continental Free Trade Area for inclusive growth, by the United Nations Conference on Trade and Development (UNCTAD) shows vehicles have the largest untapped export potential of \$1.4 billion, followed by sugar (\$1.3 billion) and fish and crustaceans (\$1.1 billion) processing.
